MUNICIPALITY OF LOUISE

FLOYD & ETHEL CUDMORE CRYSTAL CITY COMMUNITY HALL SPECIAL SERVICE LEVY

By-law #2019-01

BEING a By-law of the Municipality of Louise to establish a rate for a portion of the operation, maintenance and upgrading costs of the Floyd & Ethel Cudmore Community Hall located within the LUD of Crystal City as a special service (recreation support) for the years 2019 to 2023 inclusive.

WHEREAS Section 312 of The Municipal Act of Manitoba, provides as follows:

- 312 If approved by By-law, a municipality may provide, as special service to all or a part of a municipality, the following:
 - (g) recreation support services
 - (l) maintenance or operation of a local improvement

AND WHEREAS Section 320(1) of the Act provides as follows:

Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- (a) approve the local improvement or special service as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Municipality of Louise, in the Province of Manitoba, has prepared Special Services Proposal No. 2019-01 to establish a rate for a portion of the operation, maintenance and upgrading costs of the Floyd and Ethel Cudmore community hall located within the LUD of Crystal City as a special service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in sections 318, 319 and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Municipality of Louise, duly assembled, enacts as follows:

- 1. THAT pursuant to subsection 320(1) of *The Municipal Act*, the Municipality of Louise approves Special Service Proposal No. 2019-01 attached hereto as Schedule "A".
- 2. THAT the Municipality of Louise levy an annual special service tax upon all Class 10 (residential) properties in the urban centre of Crystal City and rural Crystal City catchment area in the Municipality of Louise and attached hereto as Schedule "B".
