

**MUNICIPALITY OF LOUISE**  
**BY-LAW # 2026-01**  
**MUNICIPAL SERVICE FEES**

**BEING** a By law of the Municipality of Louise to revise and update the fees payable for municipal services rendered under the authority of the Municipal Act and any By laws of the Municipality.


**WHEREAS** the Council of the Municipality of Louise deems it advisable to pass one (1) By law to include all fees and charges payable to the Municipality for services rendered by officers and employees of the Municipality.

**NOW THEREFORE** the Council of the Municipality of Louise in open session duly assembled hereby enacts as follows:

1. **THAT** the fees and charges payable to the Municipality of Louise for services rendered by officers and employees of the Municipality shall be as set out in the following schedule attached hereto;
2. **THAT** the fees and charges set out in the schedules attached to this By law shall take precedence over any other By law or resolution.
3. **THAT** this By law shall be known as the Municipal Service Fees By law
4. **THAT** By law 2024-11 is hereby repealed.
5. **THAT** this By Law shall come into force on the date of final reading
6. **THAT** any unpaid fees or charges owed to the Municipality by any tax payer related thereto as well as any fines imposed on the taxpayer by the court for contravention of the Municipal By laws may be added to the taxes of the said tax payer and may be collected or enforced in the same manner as a tax as defined by the Municipal Act.
